

Keynote Speaker

Richard Ford, Esq.

Athletes' Rights Advocate and Host of the BigAmateurism Podcast



Richard Ford is an athletes' rights advocate. He has been connected to athletes' rights since the 1980s through his work with Dick Devenzio, a pioneer in the field. Richard analyzes college sports regulatory, legal, and cultural issues through a values-based lens. In his podcast, *the BigAmateurism* monologues, Richard emphasizes unreported and underreported issues and narratives. Richard is co-founder and CEO of DYK Media, a new web-based educational and advocacy

outlet that will launch in April. Through original research, commentary, and content across multiple platforms, DYK hopes to make the byzantine world of big-time college sports accessible to athletes and other stakeholders. Richard spent over a decade as a litigation attorney representing clients in federal and state courts, including the United States Supreme Court. He also has academic experience as an adjunct professor, clinical advisor, and administrator in the law school setting. Richard received his undergraduate degree in Public Policy from Duke University (1984) and his law degree from the University of Georgia (1988). While at Duke, he played basketball under legendary Coach Mike Krzyzewski, going from a walk-on to a scholarship player and, ultimately, a team captain. He brings a unique perspective in his critique of big-time college sports. Richard lives in Wake Forest, NC.

Ajhanai (AJ) Keaton, Ph.D.

Assistant Professor, University of Louisville



Dr. Ajhanai "AJ" Keaton studies how race and gender (in)equity shapes organizational structures, norms, and experiences. Keaton's scholarship is interdisciplinary, as her examination of sport phenomena intersects with management, higher education, and sociological communities. As an interdisciplinary scholar, she has

published in the following peer-reviewed academic outlets: Journal of Negro of Education, Journal of Issues in Intercollegiate Athletics, and Journal of Sport Management to name a few. Her academic work is informed by the theoretical prescriptions of Black feminism, institutional theory, and critical theory.

Deanne Davis Brooks, ED.D.

Associate Professor & Graduate Program Director, University of North Carolina at Greensboro

Dr. DeAnne Davis Brooks is an AP Associate Professor and Graduate Program Director in the Department of Kinesiology at UNCG. She holds degrees in Kinesiology, Clinical Exercise Physiology, and Exercise and Sport Science, a post-baccalaureate certificate in Women's and Gender Studies, and is a Certified Exercise Physiologist, Certified Strength and Conditioning Specialist, and yoga instructor. For over twenty years, Brooks has also coached track and field at the youth and collegiate levels.

Brooks is heavily involved in equity work in higher education and athletics. She is the chair of the Equity Diversity and Inclusion Committee in the

Department of Kinesiology, contributes to the DEI Committee in the School of Health and Human Sciences at UNCG, and consults with several major athletics organizations to enhance diversity, equity, and inclusion within their programs. Brooks has also delivered lectures and workshops to student-athletes, coaches, and athletics administrators nation-wide on the topic of transitioning from competitive athletics to lifelong physical activity. She co-developed the Moving On! program to help athletes make healthy transitions to life after sports.

Natasha Hastings

Graduate Student & Graduate Assistant - Athletic Department, University of South Carolina & 2x Olympic Gold Medalist in 4x400 meter relay

Natasha Hastings is in her second season as a graduate assistant with the South Carolina track and field programs.

Hastings is one of the all-time greats in school history on the track. Hastings owns the indoor 400-meter record (50.80) and held the outdoor record until 2019. She is still No. 2 in the outdoor 400 meters with a time of 49.84. Hastings went undefeated during her junior season, taking home the 400-meter titles in both the indoor and outdoor season.

Hastings has competed in two Olympic Games (2008 and 2016) and took home gold medals as a member of the USA's 4X400-meter relay team. Hastings is also an eight-time world champion as members of the American 4X400-meter relay team.



The Intersectional experiences of Black women in college sport



Dr. F. Michelle Richardson

Assistant Professor, Coppin State University & 2023 NASSS President

Dr. F. Michelle Richardson is an Assistant Professor of Sport Management at Coppin State University in the College of Business. Her scholarly endeavors examine college athletic experiences within Historically Black Colleges and Universities (HBCU); Black sportswomen's experience as athletes, coaches, and administrators at the college and professional levels; and organizational leadership, commitment, and effectiveness within the context of sport. Dr. Richardson has a co-authored peer-reviewed book chapters Black Women's Sports Experiences Beyond the Game in the book Sports in African American Life: Essays on History and Culture, and Black Female

Athletic Experiences in the book The Sporting Life at Historically Black Colleges and Universities, as well as peer-reviewed journal articles, and national and international presentations. Her current publication with Dr. Andre Andrijiw is titled "The Lived Experiences of Black Female Hockey Fans" in the Journal of Sport Management.

As a sport educator, she is committed to serving and promoting social change through sport and beyond. Dr. Richardson is the President of the North American Society for the Sociology of Sport and sits on the Board of Directors with the Commission on Sport Management Accreditation. She is a graduate of City College of San Francisco (Associate of Arts), Howard University (Bachelor of Arts), Florida State University (Master of Science), and the University of New Mexico (Ph.D.). She is a member of Delta Sigma Theta Sorority, Incorporated.

Akilah was born in Topeka, Kansas. She grew up with a passion for sport, participating in track and field, martial arts, and volleyball at the youth and high school level. She was a member of the track and field team at the University of Houston (UH) participating in 100 meter hurdles and long jump. Sport participation and education serve as a mainstay in Akilah's life then and now. She served as the President for the North American Society for the Sociology of Sport (NASSS) (2018-2019). She served as the Executive Director for the Institute for the Study of Sport, Society and Social Change (ISSSSC) and an Associate Professor in the Department of African American Studies at San José State University (2019-2022). In the fall of 2022, Akilah will serve as the Dean for the School of Education, Health and Human Services at Benedict College - a Historically Black College - in Columbia, South Carolina, USA.

Daniel Rascher teaches and publishes research on sports business topics, and consults to the sports and entertainment industry. He specializes in economics and finance and more specifically in industrial organization, antitrust, competition analysis, M&As, valuation, analytics, econometrics, economic impact, market readiness, feasibility research, marketing research, damages analysis, class certification, strategy, and labor issues in the sports industry. Dr. Rascher founded SportsEconomics to enable sports enterprises to capitalize on the sports industry's transition from hobby status to multi-billion dollar industry. As Founder and President of SportsEconomics, LLC, Founding Partner at OSKR, LLC, and former

Principal at LECG, LLC, his clients in more than 150 engagements have included organizations involved in the NBA, NFL, MLB, NHL, NCAA, NASCAR, MLS, PGA, media, sporting goods and apparel, professional boxing, mixed martial arts, minor league baseball, NHRA, AHL, F1 racing, Indy Car racing, American Le Mans racing, Premier League Football (soccer), NASL, women's professional soccer, professional cycling, endurance sports, Indian Premier League, ticketing, IHRSA, youth sports, music, as well as the FTC, IRS, EEOC, sports commissions, local and state government, convention and visitors bureaus, tourism businesses, entrepreneurs, and B2B enterprises.

A native of California, Mark S. Nagel became a faculty member in the Department of Sport and Entertainment Management at the University of South Carolina in 2006. Prior to joining the department, Nagel was the director of the graduate sport management program at Georgia State University. At Georgia State, he was responsible for all aspects of the sport management program including recruiting and advising students, developing and scheduling courses, identifying and supervising adjunct faculty, and maintaining alumni and sport business relationships.

Nagel has also previously worked as a sport management professor at the University of West Georgia and San Jose State University. He currently serves as an adjunct faculty member at the IE Business School in Madrid, the University of San Francisco and St. Mary's College of California. Before pursuing a career in academe, Nagel worked in different areas of sport management—primarily in athletic coaching and administration as well as campus recreation. During his years as an assistant coach of the women's basketball team at the University of San Francisco, he helped lead the team to three NCAA Tournament appearances and a spot in the 1996 Sweet 16.

Nagel has co-authored nine textbooks including Developing Successful Sport Marketing Plans and Developing Successful Sport Sponsorship Plans as well as multiple editions of Introduction to Sport Management: Theory and Practice; Financial Management in the Sport Industry; and Sport Facility Management: Organizing Events and Mitigating Risks. He has also authored or co-authored numerous articles in refereed journals such as the Journal of Sport Management, Sport Marketing Quarterly, Entertainment and Sport Law Journal, International Journal of Sport Finance, and Sport Management Review. In addition, he has published extensively in professional journals as well as written numerous academic book chapters and given dozens of research presentations.

Nagel has served as treasurer for the North American Society for Sport Management and the Sport and Recreation Law Association. He has also served as the associate director of the College Sport Research Institute since its creation in 2006.

Justin Falcinelli

College Football Players Association Leadership Committee and former football player at Clemson University

Justin Falcinelli was a Clemson offensive lineman for the 2014 -2018 seasons. He was a two-year starter, first team all-ACC center, honorable mention all-American, two-time College Fooball Playoff National Champion, and receiver of Clemson's top Male Scholar Athlete award in 2018. He received a B.S. in management in 2017 and completed his MBA at Clemson in 2018 during his senior season.

He is now a Data Insight Analyst in Baltimore Maryland with 3 years experience in data visualization and cost analysis. Justin has developed multiple program management, financial, and engineering metric reporting dashboards.

Justin is a huge proponent of data-driven decision making and will bring this mindset to the CFBPA. Justin wants to give athletes a direct, impactful voice and accurate representation in the college football decision-making process through the use of modern data analysis.

Edwin Garrett

College Football Players Association Leadership Committee and former football play at University of New Mexico

Born in Youngstown, Ohio, Edwin (Ed) Garrett was a three-year starter and a five-star recruit out of high school where he was also was a three-star athlete in track and baseball. For football, he received scholarship offers from over thirty Division I schools and was once rated one of top 50 high school players in the nation.

In college he played in the late nineties and early 2000s for the University of New Mexico. He was a player on the team when they won the 1997 conference championship and participated in the Insight Bowl. Although possessing elite speed — Ed once clocked a 4.26 40-yard dash — he spent most of his college playing career as a backup safety and cornerback due to injuries.

Today, Ed is an entrepreneur, real estate investor and a high school and college athlete advocate. He started a sports recruiting and consulting company helping parents, kids, athletic trainers and coaches connect. Ed lives in the Dallas-Fort Worth area and is the owner of a pest control company. He received his college degree in business communications.



Troy Reddick

College Football Players Association Leadership Committee and former football player at Auburn University

While at Auburn University, Troy started 40 games at guard and tackle. His four years starting at Auburn included the undefeated 2004 season that culminated in a SEC championship and a Sugar Bowl victory. He was 2x Associated Press All-SEC Honorable Mention selection. As a part of the winningest class in Auburn history, Troy helped them maintain a top three winning percentage in the country over three years. In 2006, after graduating with a BA in Public Administration from Auburn University, Troy attended camp with the Chicago Bears and the NY Giants as an unsigned free agent. His professional career was cut short due to injuries after winning an Arena Bowl Championship with the San Jose Sabercats, and two other seasons with the Dallas Desperados and





Jason Stahl

Executive Director and founder of the College Football Players Association (CFBPA)

Jason Stahl is the Executive Director and founder of the College Football Players Association (CFBPA). Jason is a former faculty member in the Department of Organizational Leadership, Policy and Development at the University of Minnesota, Twin Cities. At Minnesota, he also directed one of the largest programs for first-year student experience in the nation. It was through these twin roles that Jason met and educated hundreds of college athletes over a ten-year career. In these roles, Jason took a particular interest in the lives of the 60 or so football players who he came to know in the classroom. Seen by the public as "big men on campus" Jason came instead to see the more complicated reality of their lives as "student-athletes."

Beginning in 2017, Jason became a tireless advocate for players who came to him to report an environment of player mistreatment and manipulation within the football program on campus. Over the next three and a half years, Jason worked internally at Minnesota to report what he learned from players. This advocacy work led to his demotion and subsequent resignation in the summer of 2020.


