# LETTER OF WELCOME





April 23, 2014

Dear CSRI Conference Attendees:

It's hard to believe, but it has been over seven years since the College Sport Research Institute (CSRI) was founded in early 2007. This conference, the 7<sup>th</sup> Annual CSRI Conference on College Sport, is a testament to each of you and the outstanding research that has become the hallmark of this conference. The CSRI Conference has become "the place" where ground breaking and impactful college-sport research is shared. This year's conference continues that legacy, with a program that includes:

Fifty-three peer-reviewed oral research presentations, Four academic panels, Fifty-three poster research presentations, Two keynote speeches, and Three CSRI-sponsored panel discussions.

Many of you attended the inaugural CSRI Scholarly Conference on College Sport in 2008 at the University of Memphis where Mr. Sonny Vaccaro first challenged the faculty in attendance to "...do something to make a difference..."

After Mr. Vaccoro's talk, we discussed its implications in light of our commitment to conducting theoretically grounded college sport research. We came to the conclusion CSRI could be a vehicle for making a difference by supporting: ...the study of intercollegiate athletics through a variety of methods including hosting an annual conference, sponsoring the *Journal of Issues in Intercollegiate Athletics*, coordinating joint research projects, and serving as a resource for media and other entities needing information about the business and social aspects of college sport.

I also stayed in touch with Sonny and I am proud to say we became friends. In the spring of 2009, I sent Sonny a PowerPoint of a conference presentation my daughter, Dr. Crystal Southall, and I gave– re: "Legal and Ethical Issues Related to College-Athletes' Image Rights."

Sonny forwarded the PPT to an antitrust attorney in Washington, DC – Michael Hausfeld – who agreed with our legal and ethical analysis that the NCAA was (in part through the use of its "S-A Statement") violating the Sherman Antitrust Act. *O'Bannon v. NCAA* was filed in July 2009.

That presentation was consistent with CSRI research Crystal, Dr. Mark Nagel and I have conducted on college-sport broadcasts that reveals these broadcasts reflect the NCAA's dominant commercial institutional logic. At subsequent CSRI conferences CSRI research – including Adjusted Graduation Gap (AGG) analyses, as well as examinations of the S-A Statement and the NCAA's Collegiate Model of Intercollegiate Athletics – has been shared. However, this conference has never been – and never will be – simply about promoting CSRI research or research any member of the CSRI staff or Executive Board conducts.

Thanks to the hard work and support of so many great friends and colleagues across the United States and around the world, CSRI is a thriving research institute. For the past three years CSRI has published AGG Reports in the fall, winter and spring. Dr. Woody Eckard's leadership in this effort has been notable. In addition, we have now hosted seven

conferences at the University of Memphis, The University of North Carolina at Chapel Hill, and at CSRI's new home - the University of South Carolina.

The College Sport Research Institute's mission is to encourage and support interdisciplinary and interuniversity collaborative college-sport research, serve as a research consortium for college-sport researchers from across the United States, and disseminate college-sport research results to academics, college-sport practitioners, media, and the general public.

We have also attempted to fulfill this mission by publishing the *Journal of Issues in Intercollegiate Athletics*. As a direct result of an outstanding editorial review board, JIIA has experienced tremendous growth since it published its inaugural issue in 2008. To date six-annual and two-special JIIA issues have included a total of 100 articles, while maintaining an acceptance rate in the mid-20% range. In 2014 (to date) JIIA has published an additional 4 articles:

- 2008 8 articles
- 2009 9 articles
- 2009 4 articles (Special Issue)
- 2010 15 articles
- 2011 23 articles

- 2012 18 articles
- 2013 17 articles
- 2013 6 articles (Special Issue)
- 2014 4 articles (to date)

# **KEYNOTE SPEAKERS**

#### JUSTICE BOB ORR

Justice Orr joined the Poyner Spruill law firm in 2012 as Of Counsel after a 35-year career in the public and private sector. Justice Orr served as a member of the N.C. Court of Appeals for eight years before joining the N.C. Supreme Court where he served for ten years. After retiring from the judiciary, he spent seven years as the Executive Director and Senior Counsel for the NC Institute for Constitutional Law (NCICL), a 501(c)(3) non-profit public interest organization.

Since coming to Poyner Spruill, in addition to his work in the Litigation and Appellate practice areas for the firm, Justice Orr has developed a national reputation in the



collegiate sports field through his representation of athetes in controversies rising out of eligibility rulings by the National Collegiate Athletic Association (NCAA). His work and successes have been covered nationally by the likes of NY Times columnist Joe Nocera and in such other publications as the NY Post and LA Times. Justice Orr's work in this field includes representing both athletes and universities.

#### **GENE MARSH**



Mr. Marsh has focused on collegiate sports work since 1996, with an emphasis on NCAA compliance matters relating to college athletics programs. He represents institutions, coaches and athletes.

Mr. Marsh, a Professor Emeritus at the University of Alabama's School of Law, was the University of Alabama Faculty Athletics Representative to the Southeastern Conference and the NCAA from 1996 through 2003, where he served as Chair of the University Compliance Committee, the University Committee on Intercollegiate Athletics and the NCAA Certification Committee and Self-Study Project.

He was also a member of the NCAA Business/Finance Cabinet and the NCAA Ad Hoc Committee on Financial Penalties and Forfeitures and served on an NCAA subcommittee reviewing infractions penalties. He was a member of the Working Group of the Six Major Athletic Conferences and served on the Working Group Subcommittee on Incentive Clauses in Employment Contracts. Mr. Marsh has also served on several committees for the Southeastern Conference.

Mr. Marsh has published two law review articles on NCAA investigations and the infractions process. As a frequent speaker, he has made presentations for NCAA regional compliance seminars, the National Association of Collegiate Directors of Athletics, the Faculty Athletics Representative Fall Forum, the Knight Commission on Intercollegiate Athletics, Street and Smith's Intercollegiate Athletics Forum, the Sports Lawyers Association, the National Association of College and University Attorneys, and the National Association for Athletics Compliance.

Mr. Marsh received his B.S. and M.S. from The Ohio State University (1978) and his J.D. from Washington and Lee University (1981). He served three years in the U.S. Army Infantry with the Presidential Honor Guard at Fort Myer in Arlington, Virginia.

#### Dwane Ballen, Moderator for this panel and "The Price of College Sports"

Dwayne Ballen is an award winning television sports journalist with a resume that includes: The Golf Channel, CBS Sports, Fox Sports and the ESPN Networks. He has been recognized for his outstanding skills as an interviewer and anchor. He is host of the upcoming talkshow "Sportsthought" which focuses on the more substantive issues that revolve around the world of sport. Ballen is also the author of the recently released book, *Journey With Julian*, about his family's life with his eldest son (Julian) who has autism.

#### Dr. Allen Sack, The Drake Group - University of New Haven, West Haven, Connecticut

Dr. Sack earned his a Ph.D. in sociology from Pennsylvania State University and a B.A. from the University of Notre Dame where he played on Ara Parseghian's 1966 National Championship football team. Dr. Sack is currently a professor in the college of business at the University of New Haven. He is also President of the Drake Group, a faculty controlled advocacy organization whose mission is to defend academic integrity in college sports.





#### Dr. Ellen Staurowsky, Professor - Drexel University, Philadelphia, Pennsylvania

Dr. Staurowsky is a full professor in the Department of Sport Management at Drexel University. She is internationally recognized as an expert on social justice issues in sport which include gender equity and Title IX, the exploitation of athletes, college sport reform, and the misappropriation of American Indian imagery in sport. She is co-author of the book, *College Athletes for Hire: The Evolution and Legacy of the NCAA Amateur Myth*. Dr. Staurowsky received her undergraduate degree from Ursinus College, master's degree from Ithaca College, and doctorate from Temple University.

#### Dr. Mark Nagel, Professor – University of South Carolina, Columbia, South Carolina

Dr. Nagel has been a faculty member in the Department of Sport and Entertainment Management (SPTE) at the University of South Carolina since 2006. Prior to joining SPTE, he was the director of the graduate sport management program at Georgia State University. Dr. Nagel has co-authored three textbooks: *Introduction to Sport Management: Theory and Practice; Financial Management in the Sport Industry*; and *Sport Facility Management: Organizing Events and Mitigating Risks*. Dr.Nagel's awards include the 2012 Research Fellow, North American Society for Sport Management and the 2011 Excellence in Teaching Award from the Alpha Chapter of the Mortar Board.





#### Kevin Blackistone, Professor - University of Maryland, College Park, Maryland

Kevin Blackistone is a longtime national sports columnist, a panelist on ESPN's Around the Horn, an occasional contributor to National Public Radio and co-author of *A Gift for Ron*. Blackistone is a former sports columnist for AOL Fanhouse from October 2007 to March 2011 and an award-winning sports columnist for The Dallas Morning News from September 1990 to September 2006.

#### Dr. Jay Smith, Professor - University of North Carolina, Chapel Hill, North Carolina

Jay M. Smith is Professor of History at UNC-Chapel Hill since 1990. He is the author or editor of four major books on French political and cultural history. His serious interest in college sport issues began in the wake of revelations of academic wrongdoing at UNC-Chapel Hill in 2010. In 2011 he founded the Athletic Reform Group at UNC, which is a forum that facilitates faculty engagement with both the local and national issues now surrounding the collegiate model of sport.

#### Gene Smith, Retired NCAA D-1 Football Coach

Gene Smith spent 20 years in college football, having played at Division II Mississippi College and then coaching Division I-A at the University of Southern Mississippi, the University of Arkansas, Mississippi State University and the University of Houston. Smith left the coaching carousel in 1997 and opened a CiCi's Pizza franchise in Hattiesburg, MS, successfully leading the restaurant into the top 10 percent in sales among 600+ franchises. He sold the business in 2008 and is now president of FiberVision, the recycling division of the Jones Companies headquartered in Columbia, MS.

#### Dr. B. David Ridpath, Professor – Ohio University, Athen, Ohio

Dr. B. David Ridpath, Ed.D. is an Associate Professor and the Kahandas Nandola Professor of Sport Administration at Ohio University in the Department of Sports Administration and College of Business. Dr. Ridpath has several years of practical experience in the sports industry and teaches classes in marketing, sponsorship, risk management, sports law, and issues in intercollegiate athletics. He previously served as assistant wrestling coach at Ohio from 1994-95 under legendary head coach Harry Houska. An accomplished scholar, he is a faculty fellow at the Center for College Affordability and Productivity and has four published academic book chapters, and has had writings and editorials featured in the NCAA News, Sports Business Journal, and Legal Issues in College Athletics.

Mary Willingham works in The Center for Student Success and Academic Counseling (CSSAC) at the University of North Carolina, Chapel Hill. 


